In 1977, Melissa survived a failed saline infusion abortion. Despite the initial concerns regarding Melissa's future after surviving the attempt to end her life at approximately seven months gestation, she has not only survived but thrived. With a Master's Degree in Social Work, she has worked in the fields of substance abuse, mental health, domestic violence and child welfare.

In 2012, Melissa founded The Abortion Survivors Network (ASN). Since ASN's inception, Melissa has been in contact with over 250 abortion survivors. She has testified before the United

States House of Representatives and Senate and the Australian Parliament. She is the author of *You Carried Me: A Daughter's Memoir.* Melissa, her husband and their two daughters live in Kansas City, Missouri.

#### From the Bronx to Santa Fe, VirTru has made its way to parents and pregnancy resource centers across the nation!

In January, our team launched the first monthly VirTru Live Training Call for pregnancy centers who have subscribed to VirTru. Subscribers heard from VirTru Founder Leslee Unruh as she offered wisdom on how to answer with confidence and clarity the call of an individual facing an unplanned pregnancy.

In February, we hosted our second monthly call. The topic discussed was starting or expanding a mentoring program within a pregnancy center. Subscribers heard firsthand from Alpha Center's Client Services Supervisor about the importance of mentoring relationships, how to attract good mentors and ways to avoid roadblocks in a client's path to success.

In March, the VirTru team will be hosting special guest Vicky Botsford-Matthews, President of LifeSteward Ministries, who will share how to grow a center's ministry through successful fundraising events and development strategies.


#### Abby,
